The Whidbey Camano Land Trust (Land Trust) is a vibrant, dynamic, and highly effective organization made up of, at its core, a passionate and results-oriented professional staff led by the Executive Director and equally dedicated volunteer Board of Directors. We are very much a place-based organization, with our place being the beautiful Whidbey and Camano Islands, together constituting Island County, Washington. Located northwest of Seattle, Island County includes Whidbey and Camano Islands. Our office is located on historic Greenbank Farm in Central Whidbey Island with beautiful scenery and trail access right outside the front door. Camano is accessed off Highway 20 and Interstate 5 by traveling over its one bridge at Stanwood. Whidbey can be reached by state ferry from both

Clinton and Coupeville as well as from the north on Highway 20 over the Deception Pass Bridge. Driving time between the two islands from the office is about 70 – 90 minutes.

- Achieve short and long range fundraising goals with a focus on major donors, legacy circle members and government grants.
- Spread the word of the Land Trust articulately and passionately, motivating, and inspiring people at all levels.
- Work with government officials and agencies at local, state, and federal levels to ensure the Land Trust's interests are advanced.
- Oversee regular development, revisions and implementation of conservation plans to ensure continued focus on protecting, restoring, and stewarding the highest priority lands and waters.
