OUR EFFORTS TO PROTECT LAND IN 2024 RESULTED IN EIGHT COMPLETED PROJECTS CONSISTING OF TEN TRANSACTIONS TOTALING 418 ACRES THAT CONSERVED FARMLAND, FOREST, COASTAL BLUFF, SHORELINE AND FORMER ESTUARY. OF THOSE EIGHT PROJECTS, TWO WERE CONSERVATION EASEMENTS, FIVE FEE LAND ACQUISITIONS AND ONE FACILITATED FEE LAND ACQUISITION PROJECT. THE LAND TRUST CONTINUED ITS COLLABORATION WITH THE TULALIP TRIBES, ASSISTING WITH A 21-ACRE ADDITION TO TWO PROPERTIES ACQUIRED IN 2023, NOW A CONTIGUOUS 150 ACRES TARGETED FOR FUTURE ESTUARY RESTORATION BENEFITING SALMON RECOVERY. OTHER NOTABLE PROJECTS INCLUDE THE PURCHASE OF 79 ACRES RESULTING IN THE FIRST ACQUISITION IN THE LAND TRUST'S

KEYSTONE PRESERVE WAS A LARGE STEWARDSHIP FOCUS IN 2024 INCLUDING THE CONSTRUCTION OF A VISITOR PARKING LOT AND TRAIL CONSTRUCTION TO FACILITATE FUTURE PUBLIC ACCESS. THE SITE ALSO HAD EXTENSIVE RESTORATION WORK WITH THE GRADING OF A NEW STREAM CHANNEL AND REMOVAL OF SHORELINE BULKHEAD. INITIAL WORK ON ALMOST 15 ACRES OF NATIVE PLANTS BEGAN IN THE FALL AND WILL COMPLETE IN THE WINTER OF 2025. THE STEWARDSHIP TEAM ALSO INSTALLED NEW SIGNS AND KIOSKS AT SEVERAL PUBLIC ACCESS SITES AS WE CONTINUE TO IMPROVE INTERPRETIVE MATERIAL ON OUR PROPERTIES.
